## Introduction

This annual report was prepared to provide an overview of the significant programs, events, and accomplishments that took place during 2017-2018. While not serving as a detailed historical record, it does contain important information about the past year. Selected statistics from past years are included along with reports from the President, Treasurer, and staff.

# Minister's Annual Report 2017-2018

Our first church in year in our newly rebuilt and remodeled building has been a whirlwind of activity! We instituted a number of new programs, brought back some old programs, and have been making great use of our facilities for our own purposes and for the larger community. It's been wonderful to see the building come alive this year!

It's also been wonderful to see us grow and thrive—both numerically (with double digit percentage increases in membership) and spiritually (with increased participation in programming of all kinds). We are filling the new building up, not just with people, but also with positive energy that is making a difference in people's lives and in the larger world.

Below are just a few highlights of the 2017-2018 church year:

- Celebrated our new building with a memorable Dedication Weekend, featuring an open house, special services, and a beautiful reception.
- Chartered a bus filled with Sunnyhillers to take part in the March for Our Lives in Washington—and participated in the local Pittsburgh march as well.
- Had several of our youth featured as speakers at the Pennsylvania Interfaith Impact Network annual banquet, along with civil rights activist Andrew Young.
- Started the Sunnyhill Live! performance series with a number of concerts—from trios to a big band—a silent film with live piano and clarinet accompaniment, and performances of the play Love Letters.
- Held a highly successful Pumpkin Patch fundraiser that also served as a good community and neighborhood outreach event.
- Continued to have a thriving small group ministry program—chalice circles—which included a lot of new members.
- Hosted a successful leadership development program facilitated by regional staff which drew more than 20 Sunnyhillers, half of whom have joined within the past two years.
- Received great coverage in the Post-Gazette, the Almanac and other local media outlets for various events and programs at Sunnyhill.
- Began a new adult religious education series on one Thursday each month, featuring various spiritual practices and a class on UU theology.
- Completed another year of sermon writing classes for lay members, resulting in some terrific sermons by Sunnyhillers.
- Initiated the process to receive accreditation as a Green Sanctuary congregation as outlined by the UUA.
- Contributed to many local nonprofit organizations through designated offerings and through volunteering.
- Put together energizing and inspiring worship services in our stunning new sanctuary.
- Continued to offer strong RE programs for our children and youth, with a record number of registrants.

There are many, many more highlights that I could mention as it has been an amazingly eventful year at Sunnyhill, but I'll stop there for now

#### President's Annual Report 2016-2017

This church year flew by. Last year at this time, we were getting close to moving into our newly renovated space. We were awaiting a report from our Long Range Planning Committee on how to mindfully grow our congregation. We were celebrating wonderful Sunday services, with varied music and always thought provoking and inspiring sermons. We were still moving around the South Hills and seeing the inside of way more churches than we had ever thought possible.

Four months later, we were in! Conditionally. Softly. But wonderfully. And in October, we did some astonishing things. Not only a huge celebration, the likes of which our congregation had never seen, but the Great Pumpkin invasion at the same time. A huge, successful Great Pumpkin invasion. An opportunity for newer members to sit outside in the sun with people who had been members for years, and to tell people—who had been randomly driving by our building without ever stopping—who we were and what we stood for. And we sold thousands of pumpkins. During the same time period, our DRE, Jennifer McGlothin, and our Outreach Coordinator, Bethany Thornton, held open houses for the neighborhood and for potential RE students. AND, Rev. Jim launched Third Thursdays, a new and well received adult RE program. The place was bustling.

During this church year, amazing things happened. Our pledge drive, led by Chetan Chothani, was a huge success. We renewed our Covenant with Spiritways CUUPs. The auction was a huge success. The congregation voted to launch a Green Sanctuary Certification Process. We hosted two cluster events – one a training for new board members, and the other a leadership development training. We adopted the Long Range Planning Committee proposals for membership growth. We are about to send another class of Coming of Age kids out into the world. And our membership increased by more than 60 people. Sixty wonderful, engaged, energetic people. And we have revolving art shows. And a concert series. We got our Safe Congregation Committee up and running. We enacted a Rental Policy for church space, refreshed our Safe Congregation Policy, and adopted a Firearms Safety Policy.

Meanwhile, there have been some growing pains. A church of 150 members functions differently than a church of 260. Money management changes. Governance changes. The board has been talking about what we need to do to continue to make sure our congregation succeeds in all ways, and we'll be working on that during the upcoming year. We're also looking for people interested in policies and procedures to help us. I know there are people who can look at our governing documents objectively, but kindly, and make recommendations that will keep us moving forward.

It's been quite a ride. I am incredibly appreciative of people who have stepped forward to help bail me out as best they could, and who have said yes so many times this year. 2018-2019 promises to be just as exciting. I'm honored to be on this journey with you.

Coming of Age is offered two Sundays per month and Our Whole Lives Sexuality Education Course (OWL) was offered for 9-12 graders.

Our first year in our renovated building was filled with renewed energy in our RE Classrooms. We have had many new teachers (and new students) join our program that already feel like old friends. I am grateful to the students, teachers, parents, and other volunteers that have been flexible while we learn our way around the new space.

#### Treasurer's Report for 2017-2018

I assumed the position of Treasurer in February, 2018. After reviewing the financials from 2017, it appears that The Unitarian Universalist Church of the South Hills had a solid financial year in 2017. According to the internally prepared financial statements, the Church reported total revenue and support of \$448,953.58. Expenses, excluding those related to the capital campaign, were \$339,372.54. Therefore, revenue outpaced expenses by 109,581.04. The financial statements presented are internally prepared, the annual CPA review has been completed and a draft report has been circulated to the Financial Oversight Committee for approval.

The Church maintained a strong balance sheet position. The total cash balance as of 12/31/17 was \$332,302.65, which consists of all accounts, including the Capital Campaign. As of December 31, 2016, Capital Campaign commitments totaled \$1,654,349 of which \$1,612,736 had been collected. The total source of funds for the Capital Campaign was \$ \$2,995,920, of which \$2,947,263 was expended. The Capital Campaign account consists of \$48,657 to cover any remaining costs. Overall, the Church maintained a strong financial position in 2017 and began fiscal year 2018 with a lot of momentum as we move forward in our new home.
